No comments were made during the Public Comments Period held at the beginning of the meeting that allows for comments on the agenda.

Vice-President Hughes requested the approval of the Consent Agenda (November 12th minutes, and the Outstanding Invoice Report). A motion was made by Mr. Hicks, seconded by Mr. Wilson, to approve the Consent Agenda. No discussion. Motion carried.
